#### FROM THE WONCA PRESIDENT :

#### THE FAMILY PHYSICIAN AFRICAN STYLE

The African requirement for health care that is responsive to the needs of the majority of its populations, and affordable within the limited resources available to its countries, has been recognized for a long time. In theory, primary health care must have much to offer for the continent, but the practical implications - or the lack of it - have been a source of frustration for many inside and outside the continent. Governments have too often paid at best lip service to the principles of primary care. External organizations usually provide support that focuses on specific diseases, without much thought of a rational system that should integrate this into the overall care of people and populations - a vertical, rather than horizontal programming of health care - that is problematic for effective health services delivery systems.

This was the reason for Wonca, in collaboration with others, to launch the campaign of '15 by 2015' (http:// www.15by2015.org/index.php/resources/) and rally support for an integrative, primary care base for African health care. A wonderful success of this campaign has been the recognition of its principles in the Resolution on Primary Health Care, that was adopted during the World Health Assembly in Geneva, last May (http://apps.who. int/gb/ebwha/pdf\_files/A62/A62\_R12-en.pdf). The adoption of this resolution presents a powerful opportunity for primary care development in Africa. There are most encouraging signs that at last there is a momentum building for primary health care – and with it for the role of family medicine – on the African continent.

Coming October, 25<sup>th</sup>–28<sup>th</sup>, the first truly African regional Wonca conference will take place in Johannesburg, South Africa, at the Rustenburg Civic Centre (http://saafp. org/conferences/index.php/WONCA/WONCA2009). This conference is directed at primary health care capacity building for Africa and the shaping of the family physician African style, and attuned to the many health and health care challenges this vast continent presents.

The regional conference builds upon the most interesting work of the Primafamed project (http://www. primafamed.ugent.be/) – a two-year EDULINK-ACP-EU financed project coordinated by Ghent University, Belgium. Primafamed, actually, is one of Wonca's partners in the '15 by 2015' campaign. The project brings together nine African countries from the East and the West of the continent. This is major step forward, as the Wonca map of Africa does still look a lot like 'Terra Incognita'. For a successful development of primary health care and family medicine, it is important to have a robust organization on the ground. Primafamed is directed to this and gives central stage to teaching and training. University departments (of primary health care and family medicine) play a major role, but probably even more important is the emphasis on regional collaboration and networking. The key to success in the history of Wonca has often been the ability of regional collaboration - hence the emphasis on the regional structure. Countries with comparable social, cultural and economical background and analogous population health challenges, can usually lend each other the best support. With the upcoming regional African conference, an opportunity arises to build a strong collaborative African network of Academies and Colleges of primary care & family medicine.

One of the few Wonca member organizations in West Africa is the AGPMP of Nigeria (http://www.agpmpn.org/). Their 2009 annual conference took place from 5-9 August and I had the privilege of attending and addressing this conference. The Primary Health Care resolution of the WHO took central stage in the program, and a senior representative of the minister of health and a number of state governors were present. This getting together of government and academic organization in one of the biggest African countries was another welcome sign that Africa is moving on primary care. Where resources are so limited, and infrastructure is so weak, collaboration between all involved in health care is of great importance. This is true in particular for government and professionals, the public – private partnership, that was presented at the conference by AGPMPN President Dr. Ade Tade. Evidence of a general interest came also from the involvement of the Nigerian universities and the eagerness of the media in getting the message of primary health care out to the public. I was most impressed with the relaxed content knowledge of a TV presenter who interviewed me for nearly an hour on one of the national networks.

Nigeria is strategically positioned to open more West African countries to the groundswell of primary health care. When it is possible to cash-in on this, there is ample opportunity to get primary health care under way in the continent that so desperate deserves it. The development of a 'family physician African style' including his/her training, will be a first priority. That 'family physician African style' will, when launched properly, in turn have a lot to offer to the rest of the world. The Wonca Regional Conference in Africa, in summary, could not come at a better time.

#### FROM THE CEO'S DESK:

#### HOW DOES WONCA FUNCTION IN THE EVENT OF A GLOBAL PANDEMIC?

Events relating to the recent outbreak and subsequent behavior and evolution of the H1N1 Influenza have taught the WHO and national governments very important lessons on how best to handle a global pandemic and what key measures should be in place to prevent massive outbreaks, panic reactions and high casualties.

As a global organization, Wonca will also suffer the consequences arising from such a pandemic where travel restrictions and compulsory quarantine may be instituted for those from affected regions and when possible serious illness and even death may result for those infected.

Wonca must at this time start thinking of measures it needs to take in the event of such a frightening scenario occurring to ensure that the organization continues to function as normally as possible.

#### Background

A pandemic occurs when a new H1N1 influenza or some other deadly virus to which people have no immunity emerges and starts spreading as easily as normal seasonal flu. No one knows when a pandemic will occur. Modeling suggests that once an outbreak occurs, it could spread to all major population centres in one to two weeks, with the peak incidence occurring within only 50 days

In widespread pandemics, it is possible that between a quarter and

a half of the world's population will be affected. If half get symptoms, over the course of the pandemic millions of people will be ill with flu. This might occur over a number of waves or could be in a single wave. National governments will impose drastic measures on their citizens. These measures will differ with each country but reducing inter-person contact will be the key. In high density outbreak areas, most people may be asked to stay at home and undertake self-care, (ie look after themselves at home). Depending on its severity, there may likely be travel restrictions within the country and international travels may be disrupted.

While it may be possible to maintain normal operations of the Wonca Secretariat in the early stages of a pandemic flu wave, it may not be possible to carry on as normal at the peak of the pandemic, nor for some time afterwards during the recovery phase.

Arrangements have to be in place to identify when non-essential services of the Organisation may have to be curtailed or dropped. When this point is reached will depend on the decision of the Wonca World President in consultation with the CEO and the Members of the Core Executive

A graded response to increasing threat, with specific 'trigger events', will be used so that all Wonca member organizations understand at what stages of the pandemic certain functions of the Wonca Secretariat will stop and/or start. The Wonca President in consultation with the CEO and Core Executive will make the decisions when these specific stages are reached.

The World Health Organisation (WHO) is the principle global organization responsible for the monitoring of global health threats and has currently in place a well accepted pandemic alert monitoring system. It is recommended that Wonca uses this same approach.

The WHO has defined phases in the evolution of a flu pandemic. These will allow us to plan so that we can respond in steps according to the level of threat. WHO identifies six phases, where Phase 1 is the lowest level of risk and Phase 6 indicates a pandemic period, with pandemic alert phases in between. Stage 4 is reached when human-tohuman transmission is confirmed. Stages 5-6 reflect increasing degrees of evidence for widespread global human-to-human transmission.

#### Wonca's Responses

The following are measures Wonca may want to undertake in relation to possible threats of a global pandemic

#### Inter-pandemic Period (WHO Phases 1 & 2)

- 1. The Wonca Secretariat will function as per normal
- 2. All Wonca conferences and meetings will proceed as per normal
- 3. All planned travels by Wonca key officials will proceed as usual

# Pandemic Alert phase (WHO Phases 3-6)

#### WHO Alert Phase 3

- 1. The Wonca Secretariat will function normally but will monitor changes to WHO's Pandemic Alert Phases twice a day as long as this phase is in force.
- 2. The Secretariat will keep tabs of all known travels of Wonca key personnel during this period and to inform these officers of any change in the alert levels via email or short-message-subscription (sms)

- 3. This will require that the Wonca Secretariat be given the mobile phone numbers and up-dated e-mail addresses of key Wonca personnel before their travel.
- 4. All organizing committee chairs of planned Wonca conferences or meetings of Wonca agencies will be requested to consider postponing the events if possible.

#### WHO Alert Phase 4.

- 1. Wonca Secretariat will function normally and continue to monitor the WHO Pandemic Alert Phases three times a day.
- 2. Wonca Secretariat will keep any traveling Wonca key officials informed of the WHO Alert phases by SMS three times a day as these are monitored from the WHO website or the news on radio
- 3. Wonca officials will explore possible changes in the venue and date of the meeting if travels have not started and if these meetings are due within the next two month.
- 4. Wonca officials will make all attempts to cut short the duration of the meeting and travel home as soon as possible if meetings are already in progress.
- 5. Traveling officials will keep the Wonca Secretariat informed of their progress of travel home as often as possible by sms
- 6. The internet will be the main avenue of communication between all Members of Executive, the CEO and the Wonca Secretariat. Teleconference will be reserved only for matters needing urgent resolution.
- 7. Wonca conferences and meetings of Wonca agencies will be requested not to start or continue

#### WHO Alert Phase 5

- 1. Wonca Secretariat will function as per normal.
- 2. If any one or more staff is quarantined because of contact risk measures, the Secretariat will function on the remaining skeletal staff.
- 3. If the CEO is unavailable for reasons of quarantine or illness, all urgent documents and cheques requiring his signature will be hand-delivered to him. All non-urgent ones will be kept aside until he/she is able to be present to sign.
- 4. All key officials en-route to meetings or at the meetings will turn back and head for home immediately and the Secretariat should be informed accordingly.
- 5. The internet will be the main avenue of communication between all Members of Executive, the CEO and the Wonca Secretariat. Teleconference will be reserved only for matters needing urgent resolution.
- 6. Any information on ill health of any key official of

Wonca should be made known to the Secretariat. The Secretariat will in turn make the news available to the Wonca World President, the CEO and all Members of Executive

- 7. All Wonca member organizations and agencies will be informed of the possible closure of the Wonca Secretariat if Phase 6 is reached. They will need to contact the CEO via e-mail for all urgent matters.
- 8. Urgent matters of the Organization will be dealt by the Wonca World President, the CEO and Core Executive via internet and teleconference where necessary.
- 9. In the event of the demise of the CEO, the Admin Manager will take over the day-to-day running of the Secretariat until the crisis period is over and arrangements are made for appointment of a new CEO. The Admin manager will work under and in close consultation with the Wonca World President and the Core Executive Committee.
- 10. In the event of the demise of the Wonca World President, the President Elect will take charge of the Organization as provided for in the Wonca Bylaws and Regulations.

#### WHO Alert Phase 6

- 1. This phase confirms the presence of a global pandemic.
- 2. Depending on the local measures taken by the health authorities, the Wonca Secretariat may or may not remain open and functional.
- 3. All measures listed under Alert Phase 5 will continue to operate if local measures by the health authorities permit.
- 4. It is anticipated that all activities of the Organization will by then grind to a halt with only very urgent issues needing the attention of the President, the CEO and Core Executive. This is likely to be few and far between.
- 5. The internet and phone will remain the means of communication.

During the crisis it will be very important that all Members Organizations, Members of Executive and Wonca Council adhere to the principles of the 'five Cs' – command, control, communicate, coordinate and cooperate to ensure that Wonca remains viable during the crisis period and in a position to recover fully after the crisis is over.

# WONCA EUROPE BURSARIES FOR CANCUN WORLD CONFERENCE

WONCA Europe has established a fund of US\$30,000 to support bursaries for the WONCA World Conference in Cancun, Mexico in May 2010. These bursaries will support Conference Registration, Accommodation and Travel to a maximum of US\$1,000 per person. The Host Organising Committee has agreed to reduced Registration Fees for successful applicants and has arranged low cost accommodation. The Bursaries will be available worldwide in competition to any family doctor or resident in a family doctor programme who can make a case for such a bursary and who is supported by his/her own College or Association. Up to 30 bursaries will be granted.

Applications will be received by the WONCA Europe Executive and its decisions will be final. Successful applicants will be required to submit a short report of their attendance at the Conference.

#### TAIWAN FAMILY MEDICINE RESEARCH AWARDS FOR CANCUN WORLD CONFERENCE

Please consider applying for the Taiwan Family Medicine Research Award for new primary care researchers. Two Awards will be given to support two junior and emerging researchers to travel to Cancun, Mexico, to present his/her paper at the 19<sup>th</sup> Wonca World Conference on 19-23 May 2010.

The Award is valued at US\$1,500 per recipient. This Research Award has been made possible by a generous donation from the Chinese Taipei Association of Family Medicine to Wonca.

#### Criteria

- 1. A junior researcher is defined as a person with no more than 5 peer-reviewed publications.
- 2. The researcher should be a clinical family physician.
- 3. The research topic should be on primary care.
- 4. The applicant needs to submit a full paper for the award. The paper may have been submitted for publication but not yet published.

Selection will be based on scientific merit and potential impact of the findings on patients.

#### Application

Applications must be submitted by email to the Wonca World Secretariat at admin@wonca.com.sg. The application must consist of the research paper and a covering letter demonstrating that the applicant meets the award criteria.

#### Deadline for submission

Applications must be received at the Wonca World Secretariat in Singapore no later than December 1, 2009.

#### **Results of Applications**

The results of the Research Award applications will be

made known by the end of January 2010.

#### Honorary Life Direct Membership

Honorary Life Direct Membership is awarded in recognition of contributions to the work of the Wonca Organization and/or to general practice/family medicine on a world basis.

Honorary Life Direct Membership is a category available to recognise significant contributions to Wonca in those instances where the award of Fellow would not be appropriate, but is felt that some recognition should be given. Thus, if a nominee for Fellowship is not recommended by the Nominating and Awards Committee for Fellowship, it may make a recommendation for Honorary Life Direct Membership.

All Fellows and Past Presidents of Wonca receive the award of Honorary Life Direct Membership. Council has resolved that Honorary Life Direct Membership be restricted to 25.

Nominations for the Fellowship or Honorary Life Direct Membership may be made by Member Organizations, Executive Committee or Council. Details of the merit of the candidate being proposed for the Award and a curriculum vitae should be submitted to the Chair of the Nominating and Awards Committee.

In making its recommendations, the Nominating and Awards Committee ensures that the prestigious nature of the Fellowship is at all times maintained, and that the total number of persons holding the Honorary Life Direct Membership is restricted to the number determined by Council.

The Awards are presented to the successful nominees at the ceremony at the World Conference. All nominations for the Fellowship of Wonca and Honorary Life Direct Membership must be accompanied by a detailed curriculum vitae detailing the nominee's contribution to the advancement of Wonca, his/her own organization and the discipline of general practice/family medicine on an international scale.

# NOMINATIONS SOLICITED FOR WONCA FOUNDATION AWARD

The Wonca Foundation Award has been made possible by an initial donation of ten thousand Pounds Sterling from the Royal College of General Practitioners. This Award is made once every three years at the Wonca Council Meeting. If the successful winner is in attendance, the Award is presented to him/her at the World Conference.

The Award is to be used to further the aim of "fostering and maintaining high standards of care in general practice/family medicine"

by enabling physicians to travel to appropriate countries to instruct in general practice/family medicine, and appropriate physicians from developing countries to spend time in areas where they may develop specials skills and knowledge in general practice/family medicine.

The value of the Award is determined by the Executive Committee. The current amount of the Award is GB Pounds £1,500. A certificate is given with the Award.

# Application Procedure for the Wonca Foundation Award

Applications should be submitted to the Chair of the Nominating and Awards Committee, with details of the project to which the Award would be applied, together with the candidate's credentials. A relevant curriculum vitae is required. There is no official application form.

The application should outline the specific purpose for which the Award will be used, the time frame, and how the objectives would be achieved. The recipient will be expected to furnish the Executive Committee with a detailed report of his/her activities at the conclusion of the task, and this report would be the property of Wonca. If the project should extend over more than one year, a progress report to the Executive Committee is required.

#### NOMINATIONS FOR WONCA AWARD OF EXCELLENCE IN HEALTH CARE: THE "5-STAR DOCTOR"

Nominations are called for the Wonca Award of Excellence in Health Care, otherwise known as "The 5-Star Doctor" at the Wonca Regional level.

This is an award to be conferred on physicians, who in the opinion of the Council, have made a significant impact on the health of individual and communities, through personal contributions to health care and the profession. It is instituted in an attempt to increase the global development of Family Medicine, global networking and partnership. The award is preferably given to those who are still active in the field for which they are nominated. Nominations are not limited to Wonca members.

The award will be offered on a Regional basis and on a Global basis. The Regional Awards may be awarded on an annual basis and the Global Award be awarded every third year (ie in the year of the Wonca World Conference). The Global award will take the form of a crystal trophy and a certificate.

Suitably motivated and validated nominations for Regional Awards should be submitted to the Chairman of the Nominating and Awards Committee and to the appropriate Regional President for regional consideration. The Global Award will be chosen from the recipients of Regional Awards for that triennium.

The criteria for the Wonca Regional Five Star Doctor Award are:

- 1. A nominee must have the attributes of the 5-Star Doctor (see below).
- 2. A nominee should be a serving physician in mid-career who in addition to providing regular service:
  - provides innovative services to a community or special group
  - developed services where they were previously not available
  - supports colleagues in another region, country or college and also performs academic work (teaching, research, quality assurance) of exceptional quality and relevance
- 3. A nominee can work outside his or her region, or create something that can be used outside his or her region or serve as a role model to other regions
- 4. The attributes of the 5-star doctor are:
  - a care provider who considers the patient as an integral part of a family and the community and provides a high standard of clinical care (excluding or diagnosing serious illness and injury, managing chronic disease and disability and provides personalised preventive care whilst building a trusting patient- doctor relationship
  - a decision maker, who chooses which technologies to apply ethically and cost-effectively while enhancing the care that he or she provides;
  - \* a communicator, who is able to promote healthy life-styles by emphatic explanation, thereby empowering individuals and

groups to enhance and protect their health;

- \* a community leader, who has won the trust of the people among whom he or she works, who can reconcile individual and community health requirements and initiate action on behalf of the community;
- \* a team member, who can work harmoniously with individuals and organisations, within and outside the health care system, to meet his or her patients and community's needs.

#### WONCA WORKING PARTY ON WOMEN AND FAMILY MEDICINE MEET IN THE UK

UEA, GES, LEAD and the WWPWFM – many letters, more actions, and much to tell.

Three years on from Hamilton, which generated the Hamilton Equity Recommendations (HER) Statement and the 'Ten Steps to Gender Equity', the Wonca Women's Working Party on Women and Family Medicine convened a further meeting at the University of East Anglia in Norwich, U.K. from 28 June – 3 July 2009. All Wonca regions, eighteen countries, and forty delegates came together with the aims to:

- Develop leadership potential in family medicine, especially among women doctors
- Build on strategic goals set by delegates through which they plan to impact on clinical, training and research priorities in women and children's health
- Plan strategic goals which relate to working with higher education structures and family medicine organisations to improve capacity for family medicine

• Encourage people early in their careers to develop their academic and leadership potential for service and scholarship.

Most immediate of all, we worked on proposals for future regional meetings, including a full programme of symposia and workshops for the next Wonca World Triennial in May 2010 in Cancun. We were excited to hear from our Iberoamericana Region colleagues about the Cancun meeting, and will support it in every way. We considered the important next steps in the Bylaws and Regulations, where our group has been responsible for many of the changes currently to be voted on by Council in 2010. The proposals developed with the World Executive include the creation of a Wonca Equity Committee, which can monitor all Wonca activities to ensure that equity is practised as well as preached. The Executive will champion the changes they propose at Council, and we expect that their work and ours will be greeted positively.

We also addressed capacity building, regional links, and succession planning. With a new EMRO member, we have full regional representation on our Executive, and will have the same in the 'emerging leaders' coordinating group. We are immensely grateful to all those who supported this meeting, including the Wonca World Executive, who gave both their time and finance to support the meeting. Our President Chris van Weel sent a specially recorded message of greeting, and Iona Health and Michael Kidd, Wonca World Executive Committee Members at Large, attended for the last day and we held a debriefing meeting with the Executive. #### STRENGTHENING PRIMARY CARE RESEARCH NETWORKS IN THE PHILIPPINES

Having met twice with the current Wonca World President Professor Chris van Weel in the 2004 Wonca World Conference in Orlando, when I was supported by a travel bursary, and again during the 2009 Philippine Academy of Family Physicians Annual Convention, we were all inspired by Wonca and his commitment to primary care research. Wonca's international Federation of Primary Care Research Networks is seeking to enhance clinical research by establishing research networks in various fields. Professor van Weel urged that standardized ethical review processes for such networks be established to reduce barriers to more global and collaborative practice-based research among.

Professor van Weel mentioned in a WONCA convention regarding research on otitis media that he remained optimistic that careful observational research in primary care networks will emerge as a valid and essential source of knowledge, especially about the effectiveness of interventions in primary care. It is conceivable that entire populations receiving care (not just a sample) can be incorporated into primary care network research. When one knows whether the population cared for was better or worse after intervention A, and the favorable experience is reduced or absent when intervention A is not done, and the favorable experience is replicated in another population exposed to intervention A, then what would we clinicians be prepared to conclude? Would we prefer to rely on and wait for a Randomized Controlled Trial (RCT) involving a few randomly chosen and selected patients to define evidence- based care for our patients? Is there something beyond the RCT that is needed to complete medical knowledge?

These and many more questions are part of the agenda on research for the next Wonca conference in the Philippines. The Research Committee of the Philippine

Academy of Family Physicians (PAFP) Davao, comprised of its Chair Dr. Susan T. Go, Co-Chairs Dr. Alvin Concha, Past Regional Director Dr. Maria Elinore Alba-Concha and member Dr. Sheree Mae Yap- Amper embarked an innovative project to form the very first PAFP Davao Primary care Research networks with the objective of strengthening research networks for primary health care for the benefit of patients by:

- The mutual support of research networks,
- The exchange of ideas and methodologies,
- Advocacy for the quality of research in primary care, and
- Capacity building, policy and advocacy initiatives to help secure funding, support, and study grants for research.

To determine the needs of the members who are interested in research, we surveyed in June 2009 the 55 members of the PAFP Davao Primary Care Research Networks. The needs were in descending order: 1) research made easy, 2) computer informatics, and 3) biostatistics and epidemiology. Of the 55 respondents, 40 intend to attend the three research modules of the joint PAFP National, PAFP Davao and Multicare conferences coming up this year.

Let us advocate for more family physician researchers and strengthened primary care research networks enhance primary care and health for all.

#### MICHAEL KIDD AWARDED MEMBER OF THE ORDER OF AUSTRALIA

Professor Michael Kidd was made a Member of the Order of Australia in the Queen's Birthday Honours List announced in Australia on June 8, 2009. This award was in recognition of his service to medicine and education in the areas of general practice and primary health care and through a range of professional organisations, including Wonca.

Michael was President of The Royal Australian College of General Practitioners from 2002-2006. He has been an elected member of the Wonca executive since 2004 and is currently the treasurer of Wonca, the Wonca liaison person to the World Health Organization, and the chair of the Wonca Working Party on Education. A past Professor of General Practice at The University of Sydney, he is now the Executive Dean of the Faculty of Health Sciences at Flinders University in Adelaide where he has responsibility for the School of Medicine, the School of Nursing and Midwifery and a number of research and professional education centres across South Australia and the Northern Territory, including the Centre for Remote Health in Alice Springs and the new Flinders medical program in Darwin. He continues to work as a general practitioner with a special interest in the care of people with HIV.

#### REMEMBERING LYNN CARMICHAEL: FOUNDER OF STFM

Lynn recently died at his home in Arizona at age 80. He was a friend, mentor, and teacher for many physicians throughout the country. Lynn's vision and efforts created family medicine in Florida and the US. He established the country's first family-medicine residency program at the University of Miami's medical school in the 1960s and was widely considered "one of the fathers of family medicine" in the US. He established community clinics in some of Miami-Dade County's neediest neighborhoods, serving migrant workers in Homestead and the urban poor and homeless in Liberty City and Coconut Grove. He also founded the Society of Teachers of Family Medicine and was the first editor of it academic journal. Many of his former residents and students are current leaders in the family medicine movement throughout the country.

Art Fournier, a long time colleague of Lynn's lists the following Carmichael teachings that define his wisdom and pragmatic perspective.

- "If you hold your patients' hands for 30 seconds while you take their pulse, you'll never get sued."
- "The specialist gets to a point where there's nothing more he can do. As a generalist, there's always something else you can do, even if it's just cutting the patient's toenails. He carried toenail clippers, and the old people would leave happy. He was very focused on service."
- "If you can't convince them, out live them"
- "Pediatrics is a tough discipline to master – all those congenital syndromes and all – but child care

is simple!"

- On labor and delivery "We've taken a physiologic process and turned it into pathology!"
- Lynn railed against the concept of the primary care doctor in managed care systems as a "gatekeeper", believing that "gate-keeping" established an adversarial relationship between doctors and their patients. "We're not gatekeepers" he would perpetually remind us, "we're tour guides!"

Dr. Fournier also noted that Lynn was consistently and continuously generous and loving to his patients and faculty. One of the best examples of this kindness was our annual holiday party – always hosted in Lynn's home, he encouraged faculty and residents to bring their entire families. Lynn would greet us in holiday attire – a Santa Clause suit or a Christmas tie – one he even donned lederhosen with red and green suspenders! There was a small gift under the tree, not just for the faculty, but also for their children.

Dr. Michele Dodard a former resident and colleague offered the following memories of Dr. Carmichael. Lynn's vision of family medicine transcended borders and today his name invariably comes up in discussions about global health, and workforce development in resources poor countries. He understood the true nature and the universality of the physician patient bond.

His devotion to parsimony, intimacy and his definition of the

family physician as one who is a healer wowing nature finds enhanced resonance in a country like Haiti.

Working with Lynn in Miami meant never to settle for a comfortable routine. He did not follow trends, but initiated them at a pace that was sometimes exhausting to follow. Recently, as I brought to our Social Medicine Pathway two lecturers on Afro-Caribbean religions, I was pretty satisfied with my "innovation", only to be reminded by another old timer that Lynn had invited a Voodoo priest to join his rounds in Jackson Memorial Hospital, twenty years ago!

He was very much of an intellectual but not a lofty type. If anything, he was known by his patients for his devoted personal attention, his house calls and his hand written notes.

He had no qualms about giving out his cell phone number, claiming that it was never abused by his patients.

Dr. Lawrence Silverberg a former resident offered the following remembrances of Lynn.

With support, acceptance and bravery, he facilitated the start to my career by helping me to become the first osteopathic physician accepted into a residency program at the University of Miami Jackson Memorial Hospital. Throughout his revolutionary career. Dr. Carmichael was always philosophically light years ahead. He established ethical rounds in 1974. instituting support for injured medical students, introducing sex education, establishing a model family medicine office in Coconut Grove, promoting the importance of behavioral sciences when taking care of patients-he always did so with a code of care in a class of its own. He encouraged a family medicine charting system and created an oath to ethically deal with the pharmaceutical industry.

Dr. Bob Schwartz current chair of Family Medicine at the University of Miami offered the following remembrances of Lynn, "I arrived in late 1997 to Miami not really knowing what to expect. I had of course heard of Lynn Carmichael as most of the older Chairs in Family Medicine often spoke of the founding fathers at national meetings and their contributions to our inception as a specialty. I found Lynn at that time to be a gracious host, enthusiastic about showing me the department, explaining his own philosophy and how he began the department and the residency training program. He was not bashful about describing some of the difficult political issues that he had encountered during his tenure as the head of the new specialty of family medicine, trying to help his colleagues and the students understand that not every medical problem could be solved by a technological solution or fix. Patients needed to be treated as human beings first, part of a social and psychological milieu before labeling them as carriers' of a diagnosis and a disease. His ideas about caring for patients resonated with my own belief system and I knew I had come to the right place. After spending several days with Lynn and evaluating Miami and its multi-cultural substrate, seeing what he had crafted over the prior 40 plus vears. I knew that this is where I wanted to be."

Dr. Carmichael has left an indelible imprint on our specialty and in my opinion deserves the title of founding father of family medicine. Not many people can walk in the footsteps of a true leader and visionary and I feel particularly grateful to have had the opportunity during the past eleven years to lead one of the first departments of family medicine in the country. It does carry its burden however and I am always aware that my colleagues, faculty, residents,

students, patients and the public are always looking over my shoulder, watching what we do and looking for leadership in an ever changing world. The healthcare market place and the changes that the public and the government are clamoring for all speak to the need for more well trained family physicians, physicians who are trained in the model of care first clearly enunciated by Lynn Carmichael almost 50 years ago.

#### REMEMBERING CECIL HELMAN - SOUTH AFRICAN FAMILY PHYSICIAN LEADER

Dr Cecil Helman was born in Cape Town, South Africa into a medical family, and qualified as a doctor at the University of Cape Town Medical School. He left South Africa because of the apartheid system, and then studied social anthropology at University College London.

Over the years he combined several different careers into a creative synthesis: family doctor, anthropologist, university lecturer, writer and poet. After a brief spell as a ship's doctor in the Mediterranean, he worked as a family doctor for 27 years for the National Health Service, in an around London, combining his clinical practice with a distinguished academic career.

Dr Helman was an international expert on medical anthropology – the cross-cultural study of health, illness, and medical care – and on the many different forms of healthcare and healing found worldwide. He researched everything from primary health care systems to traditional healers, in South Africa, Brazil, and elsewhere.

His textbook Culture, Health and Illness has been used in more than 40 countries since it was first published in 1984, including in over 120 universities, medical schools and nursing colleges in the USA and Canada. His recent memoir, 'Suburban Shaman: Tales from Medicine's Frontline', was described by Oliver Sacks (author of The Man Who Mistook His Wife for a Hat) as 'a beautifully written, devastatingly honest, and often very funny, account of an audacious and adventurous life.' It received widespread critical acclaim, and was given the rare honour of being selected by the BBC as a 'Book of the Week', and then serialized on BBC Radio in March 2006

He was a Visiting Fellow in Social Medicine and Health Policy at Harvard Medical School; a Visiting Professor in the Multi-cultural Health Programme at University of New South Wales, Sydney, Australia; and Hooker Distinguished Visiting Professor in the Department of Anthropology, McMaster University, Ontario, Canada.

Dr Helman lived in Britain, but re-visited South Africa frequently. He lectured to medical students, doctors, and nurses, taught courses on crosscultural health care, and had run creative writing courses for doctors. He was particularly interested in the humanistic side of medicine - especially the role of stories and narratives in medical care, and what they reveal about the inner worlds of both doctor and patient. Among his other interests were the role of metaphors and symbols in our understanding of the human body. in both illness and health: and what the Western industrialized world could learn from the healing systems of more traditional societies, when dealing with different aspects of human suffering.

#### REMEMBERING DAVID MORLEY: UK PIONEER AND TEACHER FOR UNDERSERVED PRACTICE

David Morley was Founder and President of Teaching-aids At Low Cost, a remarkable UK-based charity that has provided reference and learning materials for health workers and communities in developing countries since 1963. David was also Professor Emeritus at the Institute of Child Health, London. He has practised in Nigeria, East Africa, and India, and has also travelled in the Middle East. China and South America. Since retirement he has dedicated himself to a number of causes, most notably the challenge of meeting the information and learning needs of primary and district-level health workers. In recent years, David championed the production and distribution of e-TALC CD-ROMs containing high-quality content for health workers, and has distributed tens of thousands of these worldwide. especially to hospitals and health facilities in Africa with poor internet connectivity.

Bruce Sparks, Past Wonca President, remembered David as "a remarkable pioneer in training for underserved and underdeveloped areas. Many of you may have known of his work, such as the book, "Where there is no doctor" and other activities."

David has been a longstanding supporter and regular contributor to HIF-net, HIFA2015 and CHILD2015. Many of us have worked closely with him on health information issues in the past 20 years. Many more of us will remember him from his days in Africa and worldwide as a great clinician, teacher and innovator. David was an inventive man, whose intellect never diminished; he was always generous with his time and allowed others to flourish under his watchful eye. He will be greatly

missed. We send our sympathy to his widow Aileen, his children and grandchildren, who gave him great pleasure during his long life.
